#### 1. BLDHD MiThrive Community Health Needs Assessment (CHNA) Report Finalized

The BLDHD CHNA report represents the collective work of hospital systems, public health departments, community organizations, and residents from across northern lower Michigan who came together with a shared commitment, to understand and improve the health and wellbeing of our communities.

The findings in this report reveal both progress and persistent challenges. Residents across the Northwest Region, including Benzie and Leelanau Counties, identified top priorities to address in the coming years to improve health outcomes. These priorities reflect the interconnected nature of health, where social and structural factors play as great a role as medical care itself.

#### **Key Findings**


Analysis of primary and secondary data collected during the 2024-2026 MiThrive Community Health Needs Assessment revealed nine priorities issues in the Northwest Region. In December 2024, residents and community partners participated in the MiThrive Northwest Data Walk and Priority Setting Event. Using a criteria-based process that included severity, magnitude, impact, sustainability, achievability and health equity, participants ranked the priorities by region. The region decided to concentrate efforts on the top three priorities while acknowledging the importance of the others.

### The final top-ranked issues in the Northwest Region are as follows:



### **Next Steps**

With the completion of the MiThrive Community Health Needs Assessment, there are numerous ways to continue to take action. Many organizations are developing Community Health Improvement Plans or Implementation Strategies focused on the top-ranked priorities in their service areas and regions. Some are incorporating these efforts into their internal strategic plans, while others are leveraging the report and MiThrive Data Platform to support grant proposals and legislative advocacy, securing additional resources to address key issues. Addressing these complex community challenges requires collaboration—no single organization can tackle them alone. Whether working with others on similar or intersecting issues, partnerships are essential.

### 2. Kindergarten Oral Health Assessment (KOHA) Update

In another example of cross-jurisdictional collaboration, Benzie-Leelanau District Health Department contracts with Health Department of Northwest Michigan to administer the KOHA program in Benzie and Leelanau Counties. Dawn Marie Strehl, Regional Oral Health Supervisor, manages the program for BLDHD, Grand Traverse County Health Department, Health Department of Northwest Michigan, and Central Michigan District Health Department. Dawn Marie is a Registered Dental Hygienist and currently serves on the Michigan Board of Dentistry. Dawn Marie supervises a team of seven registered dental hygienists and an administrative lead implementing the KOHA program.

#### Highlights

- One-stop shopping at Kindergarten Round-Ups: Oral health stations are set up in conjunction with hearing and vision to streamline the process for parents. This allowed families to complete multiple health checks on a single visit.
- All schools were completed in the spring and late summer/early fall.
- Strong oral health connections: continued linking families to oral health resources as needed, reinforcing the goal of establishing a dental home before kindergarten.
- Proactive family engagement: growing response from families who are taking the initiative to schedule visits with their family dentists prior to starting kindergarten, which aligns with the oral team's ultimate objective! That all children have dental homes, and parents report this to the school.

### **Impact**

- Increased convenience for families with a one-stop assessment experience.
- Coverage of all schools
- Progress toward every child entering kindergarten with a dental home, as well as verified hearing and vision health.

### **Next Steps**

- Continue co-hosting Round-Ups with hearing, vision, and oral health partners to sustain momentum.
- Track long -term outcomes: referrals, dental home connections established, and any follow-up identified during kindergarten entry.

#### Outcomes

- Benzie County: 75 Oral Health Assessments, 1 referral for care, and 2 Urgent Care referrals
- Leelanau County: 97 Oral Health Assessments, 7 referrals for care, and 2 Urgent Care referrals

The Mi School Data website has data for the 2024/25 school year and reports 285 students in Kindergarten for both Benzie and Leelanau Counties. This number has been fairly consistent in recent years which means about 60% of incoming kindergartners have participated in the KOHA screening.

#### 3. Jean E. Chabut Public Health Advocate Award



On October 28th, I attended the Michigan Premier Public Health Conference in Muskegon. This conference was well attended with more than 500 public health professionals present. I had the privilege of presenting the Jean E. Chabut Public Health Advocate Award this year. Awardees are those who advocate for system changes that improve the health of the population they serve, especially those who are underserved; building strong relationships or mobilizing through leadership; and overcoming barriers to succeed with grace. This year's recipient was our own Debbie Aldridge. Over the past 10 years, Debbie has demonstrated incredible leadership in building and growing Community Connections. Through six certified Hubs operated by local health departments, Community Connections creates a sustainable community-based care coordination system led by Community Health Workers. Debbie has mobilized diverse partners to create a seamless referral and reporting system, secured sustainable funding, and built trust across sectors. Her leadership was instrumental in establishing contracts with Medicaid health plans and initiating billing mechanisms with both Medicaid and Medicare. It was an honor to present this award to Debbie. She has been with BLDHD

since the beginning and through her dedication and compassion has improved the lives of many families in our area. Receiving this award was a fitting tribute to Debbie, who is retiring in mid-December. She will be greatly missed by the staff and community.



### **Vaccine Recommendations**

As fall and winter respiratory virus season begins, several vaccines are available to reduce illness, hospitalizations, and deaths. With the changes made earlier this year at the Federal government level in how vaccine recommendations are considered and made by the ACIP and the CDC, I think it is important to review the current recommendations of the leading national medical organizations and MDHHS. These are the recommendations that I will be using in my agency standing orders as well as for our communications.

Both the American Academy of Pediatrics (AAP) and the American Academy of Family Physicians (AAFP) have put out their own evidence-based Immunization Schedules. Many other medical groups, including the American College of OB/GYN (ACOG) and the American College of Physicians (ACP), are also now making or endorsing these recommendations that may differ from the CDC. These recommendations are consistent with FDA approval and reflect the scientific consensus regarding the safety and benefits of immunization.

In general for all routine vaccines, the Health Department will be following and recommending the <u>AAP Child and Adolescent Immunization Schedule</u> and the <u>AAFP Schedules for Adults</u>. Please familiarize yourself with these guidelines.

### **Anaplasmosis**

Anaplasmosis, caused by Anaplasma phagocytophilum and transmitted by the blacklegged tick (Ixodes scapularis), continues to emerge in northern Michigan. Providers should maintain a high index of suspicion during tick season, as symptoms are often nonspecific (fever, headache, myalgia, malaise, GI symptoms) and lab findings may include leukopenia, thrombocytopenia, and elevated liver enzymes. Prompt treatment with doxycycline is critical and should not be delayed while awaiting lab confirmation.

#### Local Case Counts (2025):

- Benzie-Leelanau District Health Department (BLDHD): 27 cases (up from 10 cases last year)
- District Health Department no. 4: 2 cases (0 cases reported last year)
- Health Department of Northwest Michigan (HDNW): 3 cases (0 cases reported last year)



The majority of cases present between late spring and early fall. Providers are encouraged to consider anaplasmosis in patients with compatible symptoms and recent outdoor exposure, even if a tick bite was not noted. Early testing (PCR during the first week of illness, or paired serology later) is important to confirm diagnosis and support surveillance efforts. However, treatment with doxycycline should not be delayed while awaiting results, as prompt therapy reduces the risk of severe disease.


### Michigan Public Health Data Dashboards

The Michigan Public Health Data Dashboards provide public health community profiles at the legislative district level. The two dashboards include information for Michigan Senate districts and for Michigan House districts. Our service region comprises of Senate District 32, 36, and 37. Additionally, our service region at the house level comprises District 103, 104, 105, 106, and 107.

Detailed information, methodology and definitions for each public health metric, including the currently available timeframe of data, can be found directly in the dashboards. These public health metrics include data on HIV&STI, Immunizations, Social Determinants of Health, Lead Health Metrics, Opioid Overdose Deaths, Life Expectancy, Birth Metrics, Death Metrics and Premature Deaths.

The dashboards will be updated by MDHHS as new data becomes available for each metric to provide a comprehensive and up-to-date view of public health across the state.

### **Breastfeeding Resources for Your Patients**



Providers can connect new parents with their local health department for breastfeeding guidance and ongoing resources, helping families establish and sustain breastfeeding successfully.

One of the programs offered is the <u>Healthy Futures</u>. A partnership, Munson Medical Center and local health departments work together to support breastfeeding families in northern Michigan. This collaboration ensures families receive seamless care from the hospital to the community, with access to lactation consultants, education, and follow-up support.

### **Hearing and Vision Program**

Michigan's Hearing and Vision programs have been in place since 1949, screening over 1 million children annually. As required by the Public Health Code, children must be screened during preschool (ages 3-5) and again before entering kindergarten.

These screenings are FREE for all Michigan children through local health departments. Each year, more than 87,000 children are referred to eye care professionals or physicians for follow-up care, ensuring early identification and treatment of potential issues.

No child is too young to be screened. Upon diagnosis, immediate treatment increases the likelihood of remediating temporary difficulties and preventing them from becoming permanent problems.

To maintain program funding and demonstrate the effectiveness of Michigan's Hearing and Vision Screening Programs, it is essential to submit documentation confirming diagnosis, medical intervention, and treatment recommendations.

When a child is identified with a hearing or vision concern, your role is critical in ensuring timely referral to appropriate specialists. Your partnership helps to provide effective care and support for Michigan's children.

### **Gun Safety**

To help protect Michigan families, especially children, a new firearm safety law went into effect February 13, 2024. Public Act 17 of 2023 require firearms to be unloaded and secured with a locking device or stored in a locked container or lockbox when not in use, particularly when it is reasonably known that a minor may be present in the home.

Providers are encouraged to help raise awareness about this law to promote safety in the communities they serve.

Gun safety in the home is just as important as gun safety outside of the home. With hunting season underway, especially in Northern Michigan, it's important to remind patients about the risks associated with lead ammunition, both for personal safety and public health.

### **Key Concerns:**

- Lead exposure from ammunition: Lead bullets and shots are a major source of environmental contamination. Tens of thousands of tons are released annually during recreational hunting and shooting.
- Human health risks: People who eat wild game harvested with lead ammunition may unknowingly consume tiny fragments of lead that cannot be seen or felt when chewing.
- Vulnerable populations: Lead is especially harmful to developing bodies and nervous systems. Exposure during pregnancy or nursing can pass lead to the fetus or infant through the placenta or breast milk.

### Populations Most at Risk:

- · Young children and infants who consume venison
- Fetuses
- Nursing babies

#### **Recommendations for Patients:**

Providers can help reduce risk by advising:

- Avoidance of venison harvested with high-velocity lead bullets for patients who are pregnant, nursing, can become pregnant, or under age 6.
- Choosing whole cuts like steaks and chops over ground venison, which has a higher likelihood of lead contamination.
- Avoiding organ meats from wild game due to potential chemical accumulation.
- Using non-lead ammunition, such as copper bullets or shotgun slugs, which significantly reduce lead contamination.



### **Emergency Preparedness**

Emergency Preparedness is often something that our clients may not always think of. It is important to remind residents of how they can protect their health in an emergent situation.

Disability intersects every demographic group, there are people with disabilities of all ages, races, sex or national origin. And, disabilities can impact a person in a variety of ways, both visible and invisible. For people with disabilities and their families, it is important to consider individual circumstances and needs to effectively prepare for emergencies and disasters.

If you have clients who need electricity for medical equipment, offer guidance on power outages and ensuring their equipment is still able to function properly. Providers may also ask for their patients to be put on a list for priority power restoration.

### **Arborvirus Report**

In Michigan, <u>reported human arbovirus cases for 2025</u> are up to 40 as of October 10. Outbreaks of WNV have been occurring in Michigan every summer since 2002. Urban areas in Southeastern Lower Michigan and Western Lower Michigan have historically seen the most WNV activity, but notably of the 35 cases reported to date 2 were from Emmet County. Five people have tested positive for Jamestown Canyon virus (JCV) - from Alcona, Macomb, Ogemaw, Roscommon, and Washtenaw counties.

Also, of note locally is that one horse in Benzie County has tested positive for Eastern Equine encephalitis (EEE) along with several birds that have tested positive for WNV in Northern Michigan.

JCV is an arbovirus that can cause human disease. Symptoms can include fever, headache and fatigue. The virus can also cause a more severe disease including encephalitis. There are no vaccines to prevent or medicines to treat JCV. In the United States, an average of 23 JCV neuroinvasive disease cases are reported each year (2011-2022). There is significant underdiagnosis and under-reporting of less severe cases of JCV, therefore, reported neuroinvasive disease cases are used to compare trends over time and place. Most JCV cases occur from April through September, with the virus being found throughout much of the United States. Minnesota and Wisconsin have reported more than half of all cases, historically.

The most effective way to avoid reduce the risk of arboviral disease is by preventing mosquito bites.

Families can protect themselves when outdoors by using insect repellents proven safe and effective.

Those registered with the EPA contain one of these active ingredients:

- DEET
- Picaridin
- IR3535
- Oil of lemon eucalyptus (OLE) or para menthane-diol (PMD)
- 2-undecanone

For parents with babies and children, always follow instructions when applying insect repellent and in general do not use insect repellent on babies younger than two months old. The best way to apply insect repellent on a child's face is to spray the repellent directly onto your hand and then apply it to a child's face.

Another way to prevent mosquito bites is to control mosquitoes inside and outside of homes by maintaining screens on windows and doors, eliminate stagnate water that can breed mosquitoes, and keeping grass cut short and shrubs trimmed.

### Personal Health Division Board of Health Report 11/19/2025

### **Staffing Updates**

- Bobbi Scott has been promoted to Personal Health Supervisor, replacing Autumn Jurek.
   Bobbi has worked at the health department since 2020 and has been our Immunization
   Coordinator for the last couple years. She will continue in this role, and will also oversee clinical services and staff primarily in the WIC, MIHP and Immunization programs.
- The Personal Health Admin team met on 11/17/25 to evaluate all staff positions and program needs, with the goal of redistributing work to best utilize staff expertise and interests while also increasing capacity within the PH Division.
- We are seeking a mental health provider to replace a recently vacated position in our School Wellness Program at Suttons Bay Schools.

### **Program Updates**

- Harm Reduction: Beginning in March, MDHHS is offering additional Harm Reduction funding to expand Community Health Worker (CHW) roles to better evaluate and address substance use. CHWs will receive additional training in how to talk to clients about substance use, assess for substance use disorder, and connect residents to treatment and support options. Substance use disorder assessment and referrals will then be integrated into Community Connections. The \$45,000 for FY 26 will support .25 of staff time (.2 CHW and .05 outreach). Per MDHHS, it is anticipated that \$90,000 will be available in FY 27 to continue this work.
- Fall vaccine clinics continue and are almost fully booked through the end of November. The need for immunizations falls off dramatically in December. As of 11/10/25, approximately 1300 vaccines have been given this season.

### Benzie-Leelanau District Health Department Board of Health Meeting – November 19, 2025 Environmental Health Director's Report Eric Johnston

### 1. Radon Awareness Month – Give a Can, Get a Kit campaign

- Radon is a naturally occurring radioactive gas that can cause cancer. Radon enters homes through openings in the foundation floor or walls.
- One in four homes in Michigan is estimated to have indoor radon levels that exceed the federal action level.
- Traditionally, the month of January has been proclaimed by Michigan Governors as Radon Action Month in Michigan.
- In support of that proclamation, our department has provided a free radon test kit during the month of January to anyone who stops into either of our office locations and requests one.
- For the past six Januarys, we have promoted the "Give a Can, Get a Kit" campaign which requests that a non-perishable food item or personal hygiene product be donated in exchange for a free radon test kit.
- The items donated have been given to a local non-profit human services organization in the county where it was collected.
- The campaign has been a hit with the public in both counties and has led to more public awareness of the dangers of radon gas and has also helped the less fortunate in our community.
- It is our desire to continue with the Give a Can, Get a Kit campaign in January of 2026.

### 2. Michigan House Bill No. 4081 (Update)

- Bill would amend Section 108 of the Land Division Act (MCL560.108)
- It would increase, from four (4) to ten (10), the number of parcels that the first 10 acres of a parent parcel or tract could be divided into beginning one year after the bill's effective date.
- It would also allow a municipality to authorize the further partitioning of land into more parcels or tracts than allowed under Section 108 if the land met standards established by the municipality.
- The bill passed the House of Representatives (96-6) on April 22, 2025, and was discharged from the Senate Committee on Local Government on August 13, 2025.
- The bill is currently awaiting a vote by the full Senate. There is a high likelihood that the bill will pass the Senate if it comes up for a vote and the Governor will most likely sign it.
- The Michigan Association of Local Environmental Health Administrators (MALEHA) has raised concerns to lawmakers that this bill could result in the creation of parcels too small to accommodate both a well and septic system, rendering them unbuildable. However, lawmakers have expressed little concern and are unwilling to include protections in the bill to address this issue.

### 3. Food Manager Classes

- Due to demand, we will be offering another session of the National Environmental Health Association food safety course, "Food Safety Management Principles", to our area food facilities in January.
- The course covers principles necessary to maintain food safety and sanitation within the manager's operation and prepares them for the Food Safety Manager Certification Examination.
- The cost of the class is \$122.00 per person. The fee includes the course book and certification test.
- Nick Dow is the instructor and proctor for the classes.
- The Benzie class will be held at the Benzie Community Resource Center on January 6<sup>th</sup>, 2026.
- The Leelanau class will be held at the Leelanau County Government Center on January 7<sup>th</sup>, 2026.

### Director of Administrative Services Report – November 2025 Shelley Jablon

The purpose of the administration division is to manage the finances, purchasing, billing, human resources, technology and assist in the building areas of the Health Department.

#### Finance:

There were no financials included this month as I am in the process of trying to close Fiscal Year 2025. The closing of the fiscal year is taking longer than originally anticipated. As discussed at the October Board of Health Meeting I did include a breakdown of BLDHD's funding per department. Attached are graphs for both fiscal years. The breakdown shows how much State/Fed funding, grants that were received, fees that were collected, In Kind amounts given and local appropriations that were used or predicted to be used for the Personal Health and the Environmental Health Departments. I did not include the rent from Benzie Resource Center or the remodel project that was completed in 2025. As shown in the attached documents, revenue for both Departments will be lower by approximately 93% this year from last. The overall use of local appropriations for the two departments will increase by 4% for fiscal year 2026. BLDHD is anticipating collecting approximately 5% more in fees for service. It is expected that the amount received from State/Federal funding for 2026 will be about 4% lower this year than what was received last year. The amount of grant money that BLDHD should receive in 2026 will be approximately 3% lower.

### **Human Resources:**

I have been in contact with Advantage Benefits about our ancillary benefits. Our benefits coordinator has found BLDHD some cost savings by changing carriers for our short-term disability, long-term disability and employer sponsored life insurance. The initial quote from Met Life, the carrier for the listed benefits for 2025, was going to increase by approximately 31%. BLDHD will be switching to Lincoln Financial, the quoted cost for 2026 was approximately 7.5% more than the 2025 prices, which will be approximately a 23.5% savings or \$10,500.






